#### X. Vision Discussion with Elders

- Doug described how our growth is putting stress on your resources. Options to deal with this situation presented:
- 1) Two services
- 2) Temporary additions to the building to increase space (portables)

#### Comments.

- There can be negative effects on unity and community that can happen in a twoservice scenario.
- Portables is a good idea. Can children be sent out of service earlier to help with over-crowding? The Leadership has concerns about the short- and long-term effect on the spiritual growth of the children re: lack of experience and example of engaged worship.
- Two services would detract from the beauty of Evergreen as a multi-generational community.
- If everyone who has been engaged in the life of the church for 6 months were to come on the same Sunday, we would be unable to accommodate everyone. If we were to get an additional 15 kids, we would not be able to legally accommodate them. A portable would allow an extra 15-20 kids.
- Given the issues that can attend a portable, it was suggested that we build. Jeff
  explained that this will not help us immediately. Sites have been discussed, but
  no one wants to leave to go plant.
- Two services option has possibilities and opportunities for promoting more intimate fellowship.
- Is it possible to buy an existing building that would accommodate our growing needs? (Old Zellers building?) Or partnering with another building?
- Making it easier for visitors can be done by existing members making more room, sitting up at the front etc.
- Sites ought to be an option. We need to pray to discern if God wants us to do something that makes us uncomfortable.

- Leadership will create opportunities for taking feedback.
- Portables may be an interim measure.

Summary: There is little appetite for going to 2 services. We still need to act soon. Sites have some support. There is a good understanding of how every option has its difficulties. Agreed that we want to be obedient and responsive to the call and opportunity before us.
